Participants must provide proof of vaccination to attend in-person events. Proof of vaccination may be submitted via email to info@neiwpcc-jetcc.org, via fax at 207-771-9028, or be shown at the door. NEIWPCC-JETCC will not keep copies of vaccination cards. **Those unable to show proof of vaccination will not be permitted to enter the event.**

Following the U.S. Centers for Disease Control and Prevention's (CDC's) guidance, people are considered "fully vaccinated" either 2 weeks after they receive their second dose in a 2-dose series, such as the Pfizer or Moderna vaccines, or 2 weeks after they receive their single-dose vaccine, such as Johnson & Johnson's Janssen vaccine.
