




BRADFORD, CAMERON, CENTRE, CLARION, CLEARFIELD, CLINTON, CRAWFORD, ELK, ERIE, FOREST, JEFFERSON, LAWRENCE, LYCOMING, MCKEAN, MERCER, MONTOUR, NORTHUMBERLAND, POTTER, SNYDER, SULLIVAN, TIOGA, UNION, VENANGO, AND WARREN

- YELLOW is NOT a permanent designation, county status will be determined by the Secretary of Health
- YELLOW PHASE does NOT mean:
 - A mandate to call non-working employees back to work
 - A mandate to open all public facing entities
- YELLOW PHASE does mean:
 - Generally, if employees are teleworking, they should remain teleworking
 - All open worksites, should follow the Workplace Safety Guidance
 - Plans for re-opening public facing offices should be had in consultation with the Governor Office
 - Plans for shifting employees from telework to onsite needs to be submitted to the Governors Office
 - Only essential visitors should be allowed in the facilities

FACILITIES OPEN TO THE PUBLIC/RETURN FROM TELEWORK IN THE YELLOW PHASE

- Facilities will be open to the public/return from telework only when approved by the DOH, DGS, OA & Governors
 Office
- Facilities will be open to the public only if the site is ready to follow to protect both employees and customers (social distancing, plexiglass where needed, proper supplies (masks, wipes, sanitizer)
- The Commonwealth will require customers to wear masks
- The Commonwealth will NOT screen customers but will enforce masks and social distancing
- The Commonwealth will verbally screen employees (with the exception of 24/7)

DGS SUPPLY PROCUREMENT PROCESS FOR NEW SITES REOPENING

- Each agency should submit ONE Request per opening group to PEMA noting the following:
 - 1. List of offices/sites to be opened.
 - 2. Complete address and contact information suitable for shipment of Reopening Kit.
 - 3. Date of opening.
 - 4. Number of employees physically reporting to that location.


Reopening Kit Contents:

- Each kit will include: tape for marking floors, hand sanitizer, wipes (or liquid disinfectant), small quantity of gloves, and a small quantity of procedures masks.
- Agencies are herewith cautioned that the kits will not consist of a large supply, as DGS is utilizing PEMA's stocks which are intended to support local healthcare needs. Additional goods are on order, but lead times are long, and there are supply chain interruptions by COVID positive warehouses and factories.
- Employees reporting on site should have already been issued cloth face masks manufactured by Pennsylvania Correctional Industries (PCI)
- Requesting a Kit: Requesting a Reopening Kit is a 2-step process for Agencies:
 - 1. Agencies should **completely** fill out the attached spreadsheet and forward to their Agency Representative at PEMA (AREP).
 - A separate row should be completed for each location, If picking up at the Farm Show, indicate YES in column I, only include the number of employees physically working at the location for column J. Do not include staff that are teleworking.
 - a. Agency AREP completes Mission Request in WebEOC.




TELEWORK FEEDBACK BY THE NUMBERS: TEAM OPERATIONS




TELEWORK FEEDBACK BY THE NUMBERS: TEAM OPERATIONS – CONTINUED



TELEWORK FEEDBACK BY THE NUMBERS: IT TOOLS, SERVICES AND SUPPORT




TELEWORK FEEDBACK BY THE NUMBERS: IT TOOLS, SERVICES AND SUPPORT - CONTINUED




TELEWORK FEEDBACK BY THE NUMBERS: PRODUCTIVITY

Future Telework Interest




