Last week, I reached out to communicate the Allergan response to the COVID-19 pandemic. Our top priority is to ensure an uninterrupted supply of our eye care products for you and your patients.

In addition, we are announcing some enhancements to our programs for patients and physicians to support access and affordability of our medicines over the coming weeks:



Lowering our copay savings card offerings for RESTASIS[®] and RESTASIS MultiDose[®] (cyclosporine ophthalmic emulsion) 0.05%, **LUMIGAN**[®] (bimatoprost ophthalmic solution) 0.01%, **COMBIGAN®** (brimonidine tartrate/timolol maleate ophthalmic solution) 0.2%/0.5%, or ALPHAGAN[®] P (brimonidine tartrate ophthalmic solution) 0.1% and 0.15%.

From April 1, 2020 through May 31, 2020, eligible commercially insured patients pay as **little as \$0*** using the My Tears, My Rewards[®] or At Your Service programs. Patients can visit restasis.com or savewithays.com to enroll.
